Shall the City of Martelle amend Chapter 7 of the City Code by replacing existing Sections 7.03 and 7.04 which currently read as follows:

Current Language

7.03 Library Trustees. The Board of Trustees of the Martelle Public Library, hereinafter referred to as the Board, consists of five (5) members. All resident Board members are to be appointed by the Mayor with the approval of the Council. The nonresident member shall be appointed by the Mayor with the approval of the Board of Supervisors

7.04 Qualifications of Trustees. All of the members of the Board shall be bona fide citizens and residents of the City except the nonresident member and shall be over the age of eighteen (18).

Replacement Language

7.03 Library Trustees. The Board of Trustees of the Martelle Public Library, hereinafter referred to as the Board, consists of five (5) members. All Board members are to be appointed by the Mayor with the approval of the Council. At least three (3) of the members shall be residents.

7.04 Qualifications of Trustees. All of the members of the Board shall be bona fide citizens and residents of the City except the nonresident members and shall all be over the age of eighteen (18). Nonresident members shall live within ten (10) miles of the library building.
